<b>Nifty 50</b>	<b>Technical Outlook for 11-03-2026:</b> Nifty closed at 24,261.60 on 10-03-2026. Nifty remains bearish while below 24,500-25,000. Immediate support lies near 24,200, and a break below this level could extend the decline toward 24,000-23,800. Any relief bounce is likely to face resistance around 24,500.
<b>Nifty Bank</b>	<b>Technical Outlook for 11-03-2026:</b> Nifty Bank closed at 56,950.80 on 10-03-2026. Nifty Bank may attempt a relief rally toward 58,400-58,800, but a sustained recovery above 59,000 would be needed to improve the short-term outlook.
<b>BSE Sensex</b>	<b>Technical Outlook for 11-03-2026:</b> Sensex closed at 78,205.98 on 10-03-2026. Sensex: Immediate support is seen near 77,800-77,500, while resistance lies around 79,000-79,500. The overall bias remains bearish with the possibility of a short-term bounce, but a sustained recovery would require the index to reclaim levels above 80,500.
