Technical Outlook – Nifty 50, Nifty Bank and BSE Sensex	
Nifty 50	Technical Outlook for 13-02-2026: Nifty closed at 25,807.20 on 12-02-2026. Nifty is now trading above the 20 and 50 EMA, indicating slightly improving short-term momentum. Momentum indicators support a minor recovery. RSI is in the neutral-to-positive zone near 54, and stochastic reflects mild short-term strength.
Nifty Bank	Technical Outlook for 13-02-2026: Nifty Bank closed at 60,739.75 on 12-02-2026. Nifty Bank remains in a minor uptrend, trading above key EMAs (14, 21, 50). Momentum indicators like MACD and RSI slightly supports continued strength. Immediate support is at 60,090 (14 EMA) and 59,900 (21 EMA), while resistance is near 61,000.
BSE Sensex	Technical Outlook for 13-02-2026: Sensex closed at 83,674.92 on 12-02-2026. Sensex is showing mild bullish momentum, trading above few key EMAs. Momentum indicators support cautious upside potential. Immediate resistance is near 84,000, while strong support lies at 83,400 and 82,700 (200 SMA). As long as support holds, expect consolidation.
