Momentum indicators (RSI near 48, flat MACD) suggest a neutral to mildly bearish bias. Immediate resistance is placed at 25,700-25,800. A sustained move above 25,800 could revive bullish momentum toward 26,000, whereas a break below 25,500 may extend weakness toward 25,320. |
| Nifty Bank | Technical Outlook for 23-02-2026: Nifty Bank closed at 61,172.00 on 20-02-2026. Nifty Bank continues to trade in a uptrend on the daily chart, holding firmly above the 21, 50, and 200 EMAs with mild bullish alignment intact. Momentum indicators remain supportive. RSI is in the positive zone without being overbought, MACD shows strengthening mild bullish momentum. |
| BSE Sensex | Technical Outlook for 23-02-2026: Sensex closed at 82,814.71 on 20-02-2026. Sensex is consolidating after reacting from recent highs, with price hovering around short-term moving averages but still holding above the 200-day SMA, keeping the broader trend intact.
